Section 1: Summary of Major Events

Technical and Operational Update

There were no operational changes during October 2019.

Locality Update

The usTLD Locality space is monitored by Neustar to ensure adherence to policies and procedures. We now have 12,151 total usTLD Locality names. Of those, Neustar manages 9,759 as the Delegated Manager, and the remaining 2,392 are covered by external Delegated Manager Agreements. The Texas Regional Hostmaster contacted Neustar to terminate his usTLD Delegated Manager duties for the management of 324 delegated names which zone files confirm is over 850 Locality domain names. Communications and a migration plan are in process to ensure continuity of services for the affected registrants.

Policy Update:

The usTLD Stakeholder Council and Neustar held its annual Town Hall on October 24, 2019. The Town Hall is a live virtual webcast that is held once a year, that provides an opportunity for the community to hear from the .US team on the namespace developments and for community discussions on how to build and grow the .US domain to meet the demands of the future.

Featured speakers for the Town Hall discussed a rundown of the current state of the domain industry and .US specifically, plus policy considerations for domain growth, marketing and policy developments and community outreach to establish top civic priorities for future direction. Speakers included:

- Kristin Johnson — Council Secretariat, Director of Registry Global Marketing and Brand

Marketing Update:

Several marketing initiatives in October to build awareness for the .US domain as well as engage the .US community. We are proud of our fifth year of sponsorship for NASA's International Space Apps program, one of the world's largest hackathons. This 48-hour event inspires citizen teamwork for positive change across every skill level and discipline. The 2019 program produced record-breaking numbers with over 29,000 participants, in 230 locations from 80 different countries across the world. As part of the .US sponsorship, all attendees at U.S. events received a .US domain and website builder. The event was produced in approximately 30-50 cities in the USA. .US is a proud supporting sponsor of this organization and looks forward to continued participation in future events.

In addition to our partnership efforts, we also hosted the annual Town Hall on October 24, 2019. The Town Hall, as described in the section above, was promoted across all the .US owned media channels including:

Evergreen efforts that focus on continued growth and awareness included new content posted to the website, paid search marketing, social media advertising and SEO development.

There was also a new blog added in October: "Why Your Domain Name is the Best Marketing Tool Your Business Has" (<https://www.about.us/blog/why-your-domain-name-is-the-best-marketing-tool-your-business-has>) with a goal to drive SEO value and Google rankings to "domain name" searches, as well as to educate users on different ways a domain name can be leveraged to strengthen branding and marketing efforts.

Organic traffic is up 6% from the previous year and 14% from last month. Blog traffic is up 20% year over year and accounts for just under 30% of all traffic to the about.us website. Continued efforts to drive organic visibility support ongoing website health and development as demonstrated by these numbers.

Evergreen social advertising efforts are continuing throughout the year with October results:

- 140K impressions
- 1 min 28 second time on site

Overall conversion rate for October is 7.6% with paid search driving the highest conversion rate (27%) with social media at 10%, both over the website average. Campaign optimizations and audience targeting driving overall high-performance for the year-long awareness strategy.

Other Updates

New registrations in October 2019 were 71.6% lower than October 2018. Names under management in October 2019 were 3.85% lower than October 2018. The renewal rate in August 2019 (most current data available due to 45 day grace period) was higher year over year at 73.0% vs. 56.9% in August 2018.
